

MEMORANDUM OF ACADEMIC COOPERATION

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Academic Cooperation entered into by and between:

The **UNIVERSITY OF THE PHILIPPINES**, the national university, created by virtue of Act No. 1870, as amended and strengthened by Republic Act No. 9500, through its constituent university, **UNIVERSITY OF THE PHILIPPINES BAGUIO**, represented herein by its Chancellor, **RAYMUNDO D. ROVILLOS**, hereinafter referred to as the "**UPB**";

-and-

CAGAYAN STATE UNIVERSITY, created by virtue of Republic Act 1436, represented herein by its President, **URDUJAH A. TEJADA**, hereinafter referred to as "**CSU**"

WITNESSETH THAT:

WHEREAS, both universities recognize the benefits from the establishment of institutional links between them;

WHEREAS, the purpose of this agreement is to develop academic and educational cooperation and promote mutual understanding between the two universities;

NOW THEREFORE, in consideration of the foregoing premises, the parties agree as follows:

Both universities agree to develop the following collaborative activities in academic areas of mutual interest, on the basis of equality and reciprocity:

1. Exchange of faculty, researchers and other research and administrative staff;
2. Exchange of students;
3. Conduct of collaborative research projects;
4. Conduct of lectures and symposia;
5. Exchange of academic information and materials; and
6. Promotion of other academic cooperation activities as mutually agreed upon.

These activities will be conducted as required, after discussion and agreement between the duly authorized representatives of both universities;

The development and implementation of specific activities based on this agreement will be separately negotiated and agreed upon between the faculty

members, duly authorized representatives of the schools or institutes which will carry out said specific projects;

Both universities agree to comply with the laws and regulations governing the conduct of said activities after full consultation and approval with each other and the proper government agencies;

The implementation of any of the types of acts of cooperation enumerated above may be restricted based on the availability of resources and financial support available at the university concerned;

In the event that any collaborative research activity under this agreement should result in any potential for intellectual property, both universities agree to seek an equitable and fair understanding regarding the ownership and other property interests that may arise. Said understanding or agreement shall be undertaken taking into consideration the rules, regulations and guidelines implemented in each university;

Both parties shall seek prior approval through electronic mail before any distribution or publication using any logo or any and all promotional materials associated with this agreement;

This agreement may be modified or amended only by written agreement duly signed by the authorized representatives of each university;

In the event that any unforeseen incident should occur during the conduct of collaborative activities, said event resulting in a disruption of the ongoing collaborative activity, both universities agree to negotiate a mutually acceptable solution to said disruption. As far as may be practicable, these solutions shall be incorporated in the specific agreements entered into for each collaborative activity;

This agreement is valid for a period of five (5) years from the date of signing of the same by the duly authorized representatives of the parties and shall be automatically extended for another five (5) year period unless the parties agree to a renegotiation of the terms and conditions of their agreement;

This agreement, at any time during its period of validity, may be terminated by either of the parties hereto, upon prior written notice to the other which should be given not later than six (6) months before the expiration of this agreement;

Should any dispute or disagreement arise regarding the application, interpretation or implementation of this agreement, the parties shall endeavor to exercise best efforts to negotiate and settle their differences in an amicable manner; Alternative modes of dispute resolution shall be exhausted before any party may resort to court litigation;

This agreement is executed in the Philippines.
